Treating Stepfamilies

Scott Browning, Ph.D., ABPP

PROGRAM DESCRIPTION:

This presentation will clarify several fundamental research findings regarding stepfamily concerns that are often overlooked in treatment. A discussion of the literature and clinical examples will demonstrate that family therapy, without an awareness of stepfamily issues, is often insufficient to address the challenges these families frequently encounter. The presenter will share an effective treatment model developed for stepfamilies that emphasizes a subsystem-based approach (Browning, S. & Artelt, E. 2012). Clinical examples, research findings, and video excerpts will be utilized to elucidate the model and its application to participants' clinical work.

- Identify common systemic concerns often occuring in stepfamilies.
- Explain why family therapy needs to be adapted to the unique needs of stepfamilies.

Scott Browning, Ph.D., ABPP, is a Professor Emeritus of Psychology in the doctoral program at Chestnut Hill College in Philadelphia. Dr. Browning has published numerous books, chapters, and articles on a variety of topics including stepfamilies, addictions, paradoxical interventions, autism, intersectionality, empathy, and measuring treatment outcomes. Of particular note relevant to this presentation is his book, Stepfamily Therapy: A Ten-Step Clinical Approach, published by the American Psychological Association, that he co-authored with Elise Artelt, Dr. Browning has received numerous honors for scholarship and teaching excellence including the Distinguished Contribution to Family Psychology Award given by Division 43 of the American Psychological Association, the Distinguished Contribution Award from the Pennsylvania Psychological Association, and the Lindback Award for Distinguished Teaching. Dr. Browning has also served as a founding member of the Couple and Family Specialty Board of the American Board of Professional Psychology and as an editorial board member for the *Journal of Family* Transition.
